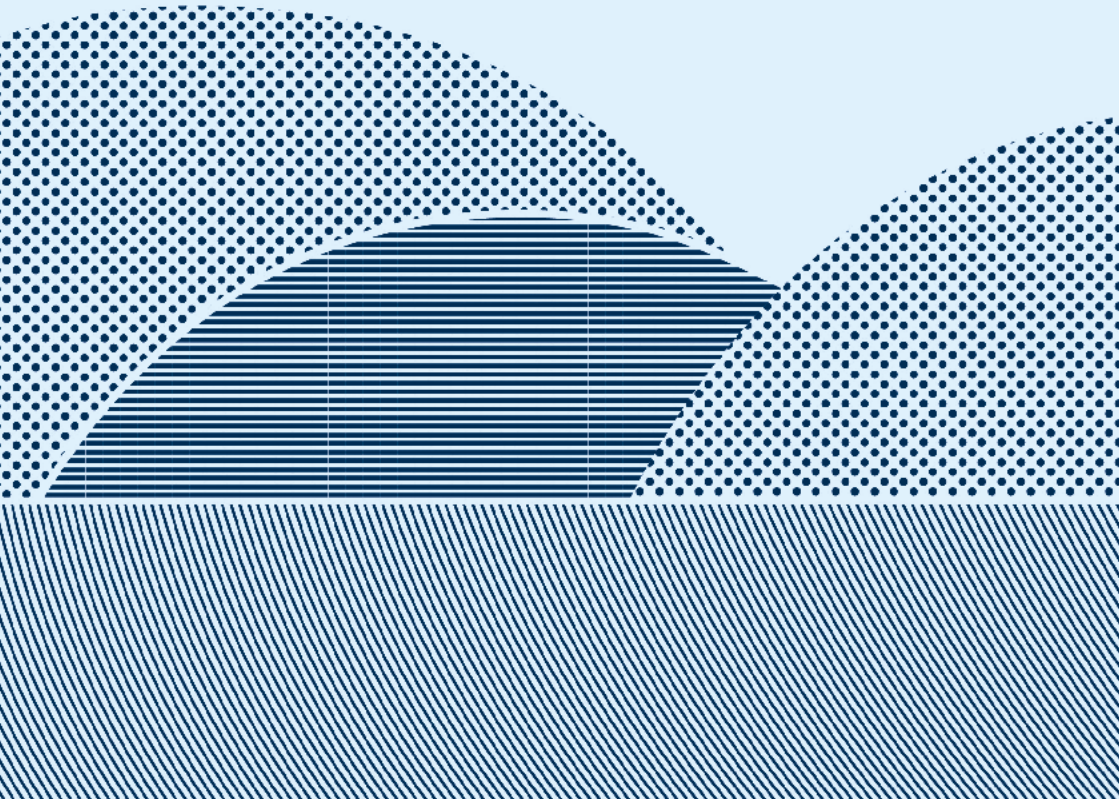

# TAKE ADVICE

---

A will is a legal document that ensures your assets are dealt with correctly and that items go to the people you wish to receive them. Your solicitor can explain your options for leaving a gift in your will, such as:

**Pecuniary gift:** a sum of money.

**Reversionary gift:** a gift of your estate after the death of your spouse or partner. This keeps your dependants secure during their lifetime.

**Residuary gift:** a share in, or all of, the remaining value of your estate after family and friends are taken care of. With a residuary gift, you will not need to change your will to keep up with inflation.

**Non-monetary gift:** a gift of a specified item such as property, a painting or jewellery.





## SUGGESTED WORDING

Here are some example paragraphs to discuss with your solicitor/legal advisor when drafting your will:

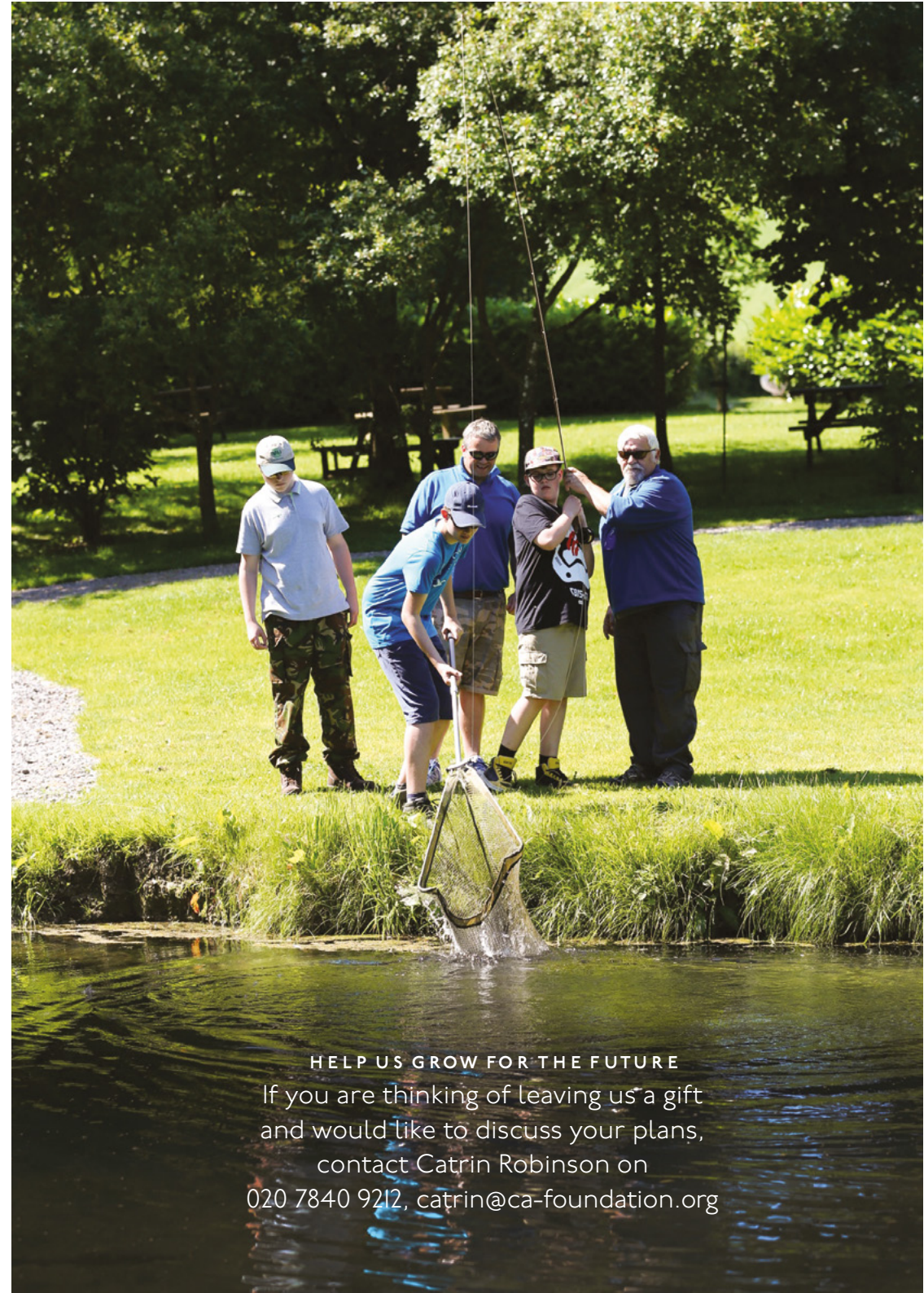
